Water Service Charges are designed to collect the annual revenue requirements necessary to fund the operation of the water system as well as to collect these revenue requirements equitably from each class of user in accordance with their differing demands placed upon the system, as determined by the 2015 Water System Master Plan Update by Carollo Engineers.

Temporary service shall be charged at 1 ½ times the appropriate flat charge, plus a quantity charge. Accounts with broken meters will use the account's average water consumption.

**B. GENERAL SERVICE, FLAT USER CLASS ELIMINATION**

The general service, flat user class shall be eliminated over time. No new applicants shall be accepted into this class and existing users shall be converted to the general service, metered class as the City converts all accounts to metered rates in accordance with sections 13.04.260 or 13.04.270 of the City's Municipal Code and the Council approved schedule for transitioning to metered rates adopted on December 14, 2016.

**C. TEMPORARY SHUT-OFF**

Temporary shut-off may be granted on the following terms and conditions:

1. A written requested is received from the customer.
2. Payment in full of the current utility bill.
3. Payment of a \$50.00 turn-off service fee
4. A service fee of \$50.00 is also required for resumption of water service.

**D. METER TESTING**

Public Works staff will test commercial and residential meters as part of its on-going maintenance. There will be no charge for these tests.

If a customer requests a meter be tested, the fee will be \$57.00 for each instance.

**E. SECURITY DEPOSITS**

Since metered accounts are billed in arrears, a deposit of \$100 will be set aside from the month the metered billing takes into effect. This deposit amount is inclusive of sewer and refuse collection services. There is no separate deposit for water service.
