USED OIL AND OIL FILTERS COLLECTION

Call WM at (866) 844-1508 to request a collection appointment for used motor oil and filters. Place used oil in a sealed container and filter in a sealed bag next to your recycling cart on your scheduled appointment day.



HOUSEHOLD HAZARDOUS WASTE (HHW)

WM's "At Your Door Special Collectionsm" provides appointment-based collection of household hazardous waste (HHW). HHW is any product labeled toxic, poisonous, corrosive, flammable, combustible or irritant. HHW items include paint, batteries, oil, pesticides, and more. Residents are eligible for two (2) appointments per year. Visit www.wmatyourdoor.com or call (800) 449-7587 to schedule an appointment and access a full list of accepted items. HHW is also accepted free of charge every Thursday, Friday and Saturday at the Yolo County Central Landfill. Limits apply. MEDICINE DISPOSAL

Residents may dispose of non-controlled, over-the-counter and prescription medicine at drop-boxes located at the Jefferson Pharmacy and Walgreens during normal business hours. Visit med-project.org for more disposal options.



FREE BULKY WASTE COLLECTION SERVICE

Residents are eligible for two (2) bulky waste collection appointments per year (July - June). Eligible items include furniture, mattresses/box springs, electronics, tires (limit 4), small and large appliances, rugs, etc. Limits apply. Set-outs exceeding limits will not be collected. Call (866) 844-1508 for more information and to schedule an appointment.



FREE BAGGED LEAF WASTE

During the fall leaf season (November 1 – January 31), bagged leaves may be placed beside the organics cart for collection. Individual bags may not weigh more than fifty (50) pounds. Paper or ATSM D6400 rated compostable bags only. No plastic trash bags. **Do Not Leave Unbagged Leaf Piles in the Street.**



CHRISTMAS TREE DISPOSAL

WM offers West Sacramento residents two convenient options for disposing of Christmas trees. From December 26 through January 24, 2027, customers can place trees next to their trash cart on their regular collection day. Trees must be free of all decorations and cut into 3-foot sections. Alternatively, customers can cut their holiday trees into smaller pieces and place them inside the organics cart for regular collection year-round. All trees must be free of decorations, and cart lids must close completely.



BACKYARD COLLECTION

Carts may be collected from backyards/sideyards for an additional fee. Qualifying senior or disabled residents can receive this service for no additional fee. Call (866) 844-1508 for details.

Cart Set-Out and General Information

Food Waste Disposal: Residents are required to put food waste and other organics in their curbside organics cart. Please refer to inside sorting panels for list of acceptable organics. Call WM at (866) 844-1508 to request a kitchen food scrap pail to contain your food waste until it can be placed in your organics cart.

Cart Set-Out: Wheel your carts to the curb by 6:00 a.m. on your collection day. Carts should be placed side-by-side at least two (2) feet apart and three (3) feet away from parked cars and other objects. Remove carts no later than 24 hours after service.

Avoid Overages: Do not overfill carts; lids must be able to close. Overage fees may apply if overfilled.

Avoid Contamination: Sort all waste properly (see the sorting guide inside this brochure). Putting unacceptable waste materials in your trash, recycling and organics cart may result in contamination charges.

Extra Cardboard: Place flattened cardboard (up to three (3) feet by three (3) feet) curbside next to your recycling cart for collection.

Extra Yard Waste: Branches and prunings no longer than three (3) feet and no wider than two (2) inches in diameter may be tied in bundles and placed beside the Organics Cart for collection. Individual bundles may not weigh more than fifty (50) pounds. Materials exceeding these limitations will not be collected.

Holiday Collection Schedule: January 1st, Thanksgiving Day, and December 25th. When a holiday lands on a regular collection day, collection will be one day later for the remainder of the week.

Trash cart contaminants includes food waste, landscape debris, wood waste, household hazardous waste and recyclables such as clean paper, cardboard, bottles and cans.

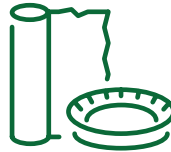

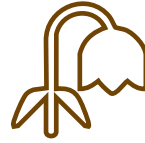

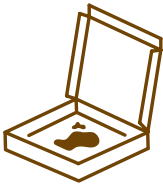
Please use paper or ASTM D6400 rated

Organics contamination fees may apply.

Organics contamination includes plastics of any kind except those specifically rated (ASTM D6400); Plastic coated paper, such as milk cartons or to-go cups; pet and human waste, kitty litter, glass, metal, rock, hazardous wastes and those items listed as trash or recycle.
